### Specific hazards arising from the chemical

# Section 6: ACCIDENTAL RELEASE MEASURES

### **Personal precautions**

# Section 7: HANDLING AND STORAGE

### **General advice**

Persons with a history of asthma, allergies, chronic or recurrent respiratory disease should not be exposed to any process in which this product is used. Examination of lung function should be carried out on a regular basis on persons spraying this product.

### Advice on safe handling

Prevent the creation of flammable or explosive concentrations of vapor in air and avoid vapor concentration higher than the occupational exposure limits.
